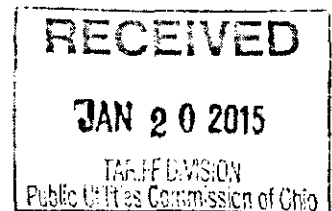
- Tickets are issued when fares are paid in cash. Boarding passes are accepted at vessel just prior to boarding.

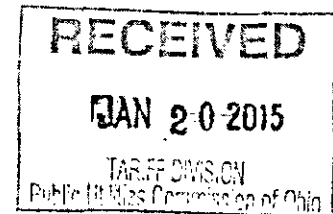

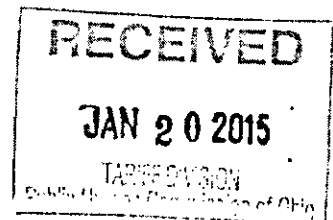
