

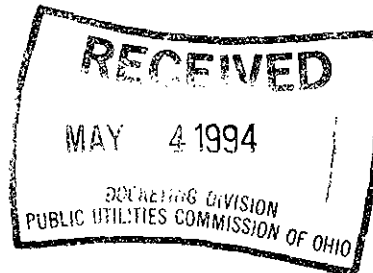

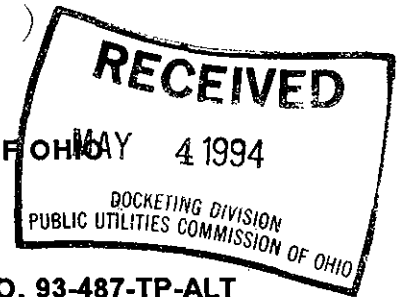


MOTION FOR APPEARANCE PRO HAC VICE



1. I am an attorney in good standing, admitted to practice in the State of Kansas. I am not admitted to practice in Ohio.


