Dear Ms. McNeal:

The December 16, 2013 Opinion, Order, and Certificate approving Northwest Ohio Wind Energy, LLC's [now known as Trishe Wind Ohio, LLC ("Trishe")] Certificate of Environmental Compatibility and Public Need ("Certificate") and the October 1, 2013 Supplement to Amended Application ("Supplement") established a set of conditions and supplemental commitments as part of the Certificate.

Within this set of conditions and commitments, **Certificate Condition No. 6** requires the following:

At least 30 days prior to the preconstruction conference, the Applicant shall submit to Staff, for review and acceptance, one set of detailed engineering drawings of the . . . [tree clearing area]. . . so that Staff can determine that the [tree clearing] design is in compliance with the terms of the certificate. The layout shall be provided in hard copy and as geographically-referenced electronic data. The [tree clearing] design shall include all conditions of the certificate and references at the locations where the Applicant and/or its contractors must adhere to a specific condition in order to comply with the certificate.

Due to the limited scope of the proposed tree clearing activities, this condition is only partially applicable. As such, a map detailing the location of the tree clearing activities was delivered to Grant Zeto of OPSB Staff on January 29, 2015. Along with detailing the location of the proposed tree clearing, this map shows the proposed crane path, and the turbines and access roads in the vicinity of the tree clearing. Thus, Trishe is in compliance with the above-mentioned **Certificate Condition No. 6** as it pertains to the limited tree clearing.
