The attorney examiner finds:

- (1) On January 27, 2015, an Entry was issued scheduling a March 19, 2015 hearing in this matter.
- (2) On March 10, 2015, Tony Lyons, on behalf of Levon LLC (Complainant), requested a continuance of the hearing.
- (3) The East Ohio Gas Company d/b/a Dominion East Ohio (DEO) filed a memorandum in response to the Complainant's request on March 10, 2015. DEO does not oppose a continuance, but requests that Complainant be required to have its counsel enter an appearance in the case no later than three weeks before the rescheduled hearing date. DEO contends that such confirmation will ensure Complainant's intent to proceed to hearing and provide DEO reason to incur the time and expense to prepare for a hearing.
- (4) The attorney examiner finds that Complainant's request for continuance should be granted. Accordingly, the March 19, 2015 hearing should be continued to a date set by subsequent entry.
- (5) In addition, the attorney examiner finds that, if Complainant wishes to proceed to hearing, counsel for Complainant must file a notice of appearance no later than April 3, 2015, and indicate in the notice dates that Complainant finds suitable for hearing. If the requisite filing is not provided by Complainant by April 3, 2015, the Commission may dismiss the complaint for lack of prosecution.

ORDERED, That Complainant's motion for continuance of the hearing is granted. It is, further,

ORDERED, That the March 19, 2015 hearing be continued to a date set by subsequent entry. It is, further,

ORDERED, That, no later than April 3, 2015, counsel for Complainant file a notice of appearance, and indicate in the notice dates that Complainant finds suitable for a hearing. It is, further,

ORDERED, That a copy of this Entry be served upon all parties of record.
