Dear Mr. O'Dell:

The Ohio Power Siting Board's April 28, 2014 Certificate of Environmental Compatibility and Public Need issued in Case No. 13-1752-EL-BGN incorporated the Notice of Filing List of Commitments docketed on February 5, 2014 and the Joint Stipulation and Recommendation filed on March 10, 2014, both of which established conditions that are to be completed prior to certain construction activities.

Condition 18 of the Joint Stipulation and Recommendation requires that Carroll County Energy provide copies of various permits and authorizations to Staff prior to the commencement of construction activities that require those permits or authorizations. In addition, Condition 19 of the Joint Stipulation and Recommendation requires Carroll County Energy to provide copies of all NPDES permits seven days prior to the preconstruction conference.

In compliance with Conditions 18 and 19, please find enclosed a disk containing the following permits, authorizations and background documents for Staff's use:

- 9. Stormwater Pollution Prevention Plan;
- 10. Hazardous Materials and Chemical Spill Prevention and Response Procedure;
- 11. ODOT Driveway Permit Gas Metering Station;
- 12. ODOT Driveway Permit Gas Metering Station Exhibits;
- 13. ODOT Driveway Permit Main Site Access;
- 14. Ohio EPA Air Permit;
- 15. ODOT Stack Construction Permit HRSG 1;

In addition to Condition 18, the Notice of Commitments included a requirement (Commitment 9) for Carroll County Energy to submit a herbicide plan to Staff for review prior to the commencement of construction. It is our understanding that because herbicides will not be used in the construction or maintenance of right-of-ways for the electric generation facility, that no plan is required to be submitted to Staff at this time.
