Dear Ms. McNeal:

This letter is to inform the Ohio Power Siting Board ("OPSB") Staff that Dominion East Ohio ("DEO") is in compliance with OPSB Staff Report of Investigation Conditions Nos. 1, 4, and 5 issued March 20, 2015, and as agreed to by DEO in its Supplement filed March 23, 2015.

Condition No. 1 states that DEO shall obtain and comply with all applicable permits and authorizations as required by federal and state laws and regulations for any activities where such permit or authorization is required. All requisite permits have been obtained, except for the Stormwater Pollution Prevention Plan ("SWPPP"). DEO is waiting on SWPPP signoff from the city of Cleveland Heights, and once it is received DEO will submit it.

Condition No. 4 states that general construction activities shall be limited to the hours of 7:00 a.m. to 7:00 p.m., or until dusk when sunset occurs after 7:00 p.m. Applicant is also limited in impact pile driving and hoe ram operations, rock drilling and blasting operations, if required. Finally, Applicant shall notify property owners or affected tenants of upcoming construction activities. DEO will comply with these general construction activities.

Condition No. 5 states that the Applicant must adhere to the seasonal cutting dates of October 1 through March 31 for removal of suitable Indiana bat habitat trees unless coordination with Ohio Department of Natural Resources and the U.S. Fish and Wildlife Services allows a different course. No Indiana bat trees will be impacted by this project, and thus DEO is in compliance with this condition.
