Dear Ms. McNeal:

The Ohio Power Siting Board's April 28, 2014 Certificate of Environmental Compatibility and Public Need issued in Case No. 13-1752-EL-BGN incorporated the Notice of Filing List of Commitments docketed on February 5, 2014 and the Joint Stipulation and Recommendation filed on March 10, 2014, both of which established conditions that are to be completed prior to certain construction activities.

Condition 14 of the Joint Stipulation and Recommendation provides as follows:

(14) The Applicant shall provide a copy of any floodplain permit required for construction of this project, or a copy of correspondence with the floodplain administrator showing that no permit is required, to Staff within seven (7) days of issuance or receipt by the Applicant.

Please find attached a copy of the correspondence from Ms. Tammy Dowdell, Carroll County Flood Plain Administrator to Michael Settineri indicating that no floodplain permit is required for the Carroll County Energy facility.



Dear Mr. Settineri:

To follow up on our conversation on March 18, 2015, I have reviewed the Carroll County, Ohio floodplain maps for the area where the Carroll County Energy electric generation plant will be located. My review of the Carroll County floodplain maps indicates that the facility will not be located in a floodplain and therefore no floodplain permit is required for the Carroll County Energy facility, to be located at 2022 Kensington Road NE, Carrollton Ohio 44615.

It is also my understanding from our discussion that the facility is a major utility facility permitted by the Ohio Power Siting Board. Pursuant to Section 3.9(C) of the Carroll County Floodplain Regulations, "[m]ajor utility facilities permitted by the Ohio Power Siting Board under Section 4906 of the Ohio Revised Code," are exempt from the general requirement to apply for a floodplain development permit.
