### THE DAYTON POWER AND LIGHT COMPANY NOTICE OF FINAL SETTLEMENT COSTS FOR THE CLOSING OF EAST BEND TRANSACTION

The Dayton Power and Light Company ("DP&L") hereby provides notice that a final accounting and true-up for pre-paid items and costs incurred prior to the closing has taken place with respect to the sale to Duke Energy Kentucky, Inc. ("DEK") of DP&L's 31% interest in East Bend Unit 2, which closed effective December 30, 2014. The closing took place consistent with the Purchase and Sale Agreement ("PSA") that was previously provided to the Commission. As provided in section 3.2 of the PSA, the final compensation was to be established once a final accounting was made of various adjustments. The adjustments included true-ups of actual costs incurred, but not yet billed while DP&L was an owner, the return to DP&L of certain pre-paid amounts such as coal inventory and pension assets, and other adjustments as set forth in the PSA.

The cash compensation received at Closing on December 30, 2014, was \$10,595,594.11. The final accounting and true-ups resulted in an additional amount received by DP&L on March 6, 2015, of \$179,893.62.
