On April 7, 2014 Cincinnati Bell Wireless announced that it had entered into an agreement to sell its wireless spectrum license and certain related assets to Verizon Wireless. Under this agreement Cincinnati Bell Wireless ceased Wireless operations on 3/31/15. With this cessation, CBW is filing to relinquish its Wireless Certificate effective 4/1/15.
