Dear Ms. McNeal:

The Ohio Power Siting Board's April 28, 2014 Opinion, Order, and Certificate approving Carroll County Energy LLC's ("CCE") Certificate of Environmental Compatibility and Public Need to Construct an Electric Generation Facility incorporated the Notice of Filing List of Commitments docketed on February 5, 2014 and the Joint Stipulation and Recommendation filed on March 10, 2014, both of which established commitments and conditions that are to be followed.

Condition #6 of the Joint Stipulation and Recommendation provides that:

With the exception of trees that exhibit suitable Indiana bat habitat, the Applicant shall not commence any construction of the facility until it has a Interconnection Service Agreement or Interim Interconnection Service Agreement with PJM, signed or filed unsigned with the Federal Energy Regulatory Commission, which includes construction, operation, and maintenance of system upgrades necessary to reliably and safely integrate the proposed generating facility into the regional transmission system. The Applicant shall provide a letter stating that the Agreement has been signed or a copy of the signed Interconnection Service Agreement to Staff.

In compliance with Condition #6, this letter serves as notice that an Interconnection Service Agreement has been executed by AEP Ohio Transmission Company, Inc., Carroll County Energy LLC and PJM Interconnection, L.L.C.
