JOINT STIPULATION AND RECOMMENDATION

NRG Ohio Pipeline Company LLC ("NRG Ohio Pipeline" or "Applicant") and the Ohio Edison Company, The Cleveland Electric Illuminating Company, and American Transmission Systems, Inc. (collectively, "FirstEnergy Intervenors")¹, agree to the following condition, resolving all matters between them pertinent to the approval and construction of a twenty-mile high-pressure steel natural gas pipeline in Lorain County, Ohio ("Project" or "Facility")²:

The Applicant shall provide FirstEnergy Intervenors, as reasonably necessary, with drawings and other technical information for the construction of the pipeline within, or adjacent to, FirstEnergy Intervenors Electric Infrastructure, which includes, without limitation, existing transmission and distribution circuits, electric distribution and/or transmission line right-of-way and/or corridors and substation sites ("Electric Infrastructure"). Applicant shall reach an agreement with FirstEnergy Intervenors on the location and other details of the pipeline located within FirstEnergy Intervenors' Electric Infrastructure and shall obtain necessary land rights to permit the use of FirstEnergy Intervenors' Electric Infrastructure by Applicant prior to the construction of the pipeline located within FirstEnergy Intervenors Electric Infrastructure.
