Thank you for contacting the Ohio Power Siting Board (OPSB). Your correspondence regarding the proposed Gable Substation Project will be docketed in the public comments for case number 14-1280-EL-BSB.

The adjudicatory hearing in this case was held earlier today, April 23, 2015, in Columbus. During the adjudicatory hearing, AEP Ohio Transmission Company and OPSB staff offered expert testimony supporting their positions before an administrative law judge. At a later date, The Board will schedule the project for a decision during a public Board meeting.
