Memorandum in Support of Motion of Xencom Green Energy, LLC

For

Extension of Certificate Expiration Date

Xencom Green Energy, LLC, is a provider of power broker services, certified by the Public Utilities Commission of Ohio in the above-referenced proceeding under Certificate No. 13-685E(1). Such Certification is effective April 29th, 2013 and is valid for two years making the Certificate expire April 29th 2015. Ohio Administrative Code Rule 4901:1-24-09(A) requires that an aggregation and power broker file an application for renewal of its Certificate no less than and no more than 60 days prior to the Certificate's expiration date.

Xencom Green Energy, LLC filed the renewal application for renewal of the Certificate on April 22, 2015 which did not allow for the full 30 days to review the application prior to expiration. This tardiness was due to unfamiliarity with the renewal process as this is Xencom's first renewal.
