MEMORANDUM IN SUPPORT

On May 20, 2013 DNE Sales was granted Ohio Competitive Natural Gas Aggregator/Broker Certificate No. 13-305G (1), effective through May 19, 2015.

O.A.C. Rule 4901:1-27-09 provides that a renewal application be filed between 60 and 30 days before expiration of a competitive natural gas service provider certificate. Due to an administrative oversight, DNE Sales' current renewal application was not filed by the April 19, 2015 deadline but was filed on April 20, 2015. Because the Rule contemplates at least 30 days for the Commission to review a renewal application, DNE Sales requests an extension of the expiration date of its current certificate for a reasonable period of time so as to allow the Commission the opportunity to evaluate Applicant's renewal application. O.A.C. Rule 4901:1-27-02(B) allows the Commission to waive any of the rules in Chapter 4901:1-27, for good cause.

For the foregoing reasons, DNE Sales respectfully requests the Commission grant this Motion to Extend Expiration during the period in question.
