**MOTION FOR PERMISSION TO APPEAR PRO HAC VICE OF JASON KEYES**

Pursuant to Gov.Bar R. XII(2)(A)(6), Jason B. Keyes, attorney for the Interstate Renewable Energy Council, Inc. (IREC), hereby moves the Public Utilities Commission of Ohio (Commission) to grant Mr. Keyes permission to appear pro hac vice.



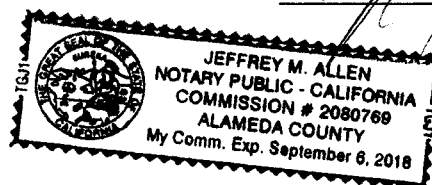
