PLAINTIFF'S MOTION TO AMEND

Pursuant to OAC 4901-1-06, Plaintiff, Gail Lykins, respectfully requests that she be permitted to amend the February 6, 2016 administrative complaint that she has filed in this matter, so that Jeffrey Pitzer is substituted as the personal representative of the estates of Dorothy Easterling and Estill Easterling III. Due to health concerns, Ms. Lykins has stepped down as fiduciary for both estates, pending in the Probate Court of Hamilton County, Ohio. On March 3, 2015, Jeffrey Pitzer was substituted as fiduciary of the estate of Estill Easterling III, and, on March 20, 2015, he was substituted as fiduciary of the estate of Dorothy Easterling.

Ms. Lykins and Mr. Pitzer further suggest that resubmission of the administrative complaint/letter is not necessary, since the allegations being asserted have not changed. Rather, Ms. Lykins and Mr. Pitzer respectfully request that the substitution simply be entered of record.
