FINDING AND ORDER

The Commission finds:

- (1) R.C. 4905.10 provides an annual assessment based upon the intrastate gross earnings of each public utility and railroad for the purpose of maintaining the operations of this Commission. In order to calculate such assessment, R.C. 4905.14 requires every public utility to file an annual report at the time and in the form prescribed by the Commission. R.C. 4905.03(A) defines public utility companies to include telephone companies, electric light companies (except regional transmission organizations), heating or cooling companies, natural gas distribution companies, pipeline companies, water-works and sewage disposal system companies. R.C. 4907.02 and R.C. 4907.20 require railroads, bridge and water transportation companies to comply with the Commission's reporting requirements. R.C. 4928.06 and R.C. 4929.23 require certified competitive retail electric service (CRES) and certified retail natural gas (CRNG) providers, as well as governmental aggregators, to file annual reports of sales and receipts for those services for which are subject to certification under R.C. 4928.08 and 4929.20, respectively.
- (2) On January 22, 2014, the Commission issued an Entry in Case No. 14-01-AU-RPT directing each reporting company to submit via the Commission's on-line system by April 30, 2014 its 2013 annual report, which details the company intrastate gross revenues for that operating year. The Commission's Fiscal Division then calculated the 2014 statutory fiscal assessment amount for each company based on the 2013 annual fiscal report, and sent an invoice to each company on September 30, 2014, with payment due by October 28, 2014. On December 1, 2014, past due notices were sent to all companies for which payment had not been received.

- (3) On April 8, 2015, the Commission issued an Entry in Case No. 15-01-AU-RPT directing the 42 listed companies to pay the 2014 annual fiscal assessments owed to the Commission and/or the Ohio Consumers' Counsel (OCC) by April 30, 2015, or show cause why their 46 listed certificates or operating authorities should not be revoked. The Commission notes that in some instances the 2014 annual fiscal assessment amount included on the April 8, 2015 attachment was incorrectly displayed due to a clerical error, and that the correct assessment amounts have now been paid or are correctly listed on the attachment to this Finding and Order.
- (4) According to the records of the Commission and OCC, the companies listed on the attachment to this Finding and Order have failed to comply with the April 8, 2015 directive and have not paid their 2014 annual fiscal assessments. Consequently, each listed active certificate on the attachment to this Finding and Order should now be revoked.
- (5) Each listed company must now immediately cease providing regulated service in the state of Ohio under the listed certificate, and immediately notify any Ohio jurisdictional customers still being served thereunder that the company is no longer permitted to operate under such authority. Any company that continues to provide regulated service under a cancelled certificate or operating authority may be subject to a forfeiture up to \$10,000 per day under R.C. 4905.54.
- (6) The Docketing Division is directed to notify each listed company of the revocation of its certificate via certified mail in addition to any other means of service, cancel all applicable tariffs, and remove each listed certificate or operating authority from the Commission's regulated company list. Further, the Commission's Fiscal Division is directed to assign the indicated unpaid 2014 annual fiscal assessment or forfeiture amount to the Attorney General for collection.

It is, therefore,

ORDERED, That each company listed on the attachment to this Finding and Order will have their active certificate or operating authority revoked. It is, further,

ORDERED, That each listed company immediately cease providing regulated service in the state of Ohio under the listed certificate, and immediately notify any Ohio jurisdictional customers still being served thereunder that the company is no longer permitted to operate under such authority. It is, further,

ORDERED, That the Docketing Division cancel all applicable tariffs, and remove each certificate or operating authority of the companies listed on the attachment to this Finding and Order from the Commission's regulated company list. It is, further,

ORDERED, That the Commission's Fiscal Division assign the indicated unpaid 2014 annual fiscal assessment and/or forfeiture amounts to the Attorney General for collection. It is, further,

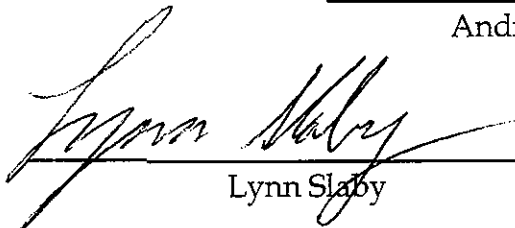
