ENTRY

The attorney examiner finds:

- (1) Ohio Power Company d/b/a AEP Ohio (AEP Ohio) is a public utility, as defined in R.C. 4928.02, and, as such, is subject to the jurisdiction of this Commission.
- (2) On May 19, 2014, the Commission final filed with the Joint Committee on Agency Rule Review (JCARR) an amended rule in Ohio Adm.Code 4901:1-10-05, with an effective date of May 29, 2014, that required electric utilities to file proposed advanced meter opt-out service tariffs.
- (3) On June 27, 2014, AEP Ohio filed an application in this case for approval of its proposed advanced meter opt-out service tariff. AEP Ohio's proposed advanced meter opt-out service tariffs would provide customers who are scheduled to receive an advanced meter with the option to retain their traditional meter. Additionally, AEP Ohio's proposed tariffs would provide customers who currently have an advanced meter with the option to have it replaced with a traditional meter.
- (4) On July 18, 2014, the Ohio Consumers' Counsel (OCC) filed a motion to intervene and a memorandum in support. Thereafter, on April 27, 2015, Ohio Partners for Affordable Energy (OPAE) filed a motion to intervene and a memorandum in support. Thereafter, the attorney examiner granted the motions to intervene filed by OCC and OPAE.
- (5) On March 23, 2015, a Stipulation and Recommendation signed by Staff and AEP Ohio was filed in this case.

- (6) This case proceeded to hearing on May 7, 2015. During the hearing, parties requested 30 days to file post-hearing briefs and 15 days to file reply briefs. Thereafter, the hearing transcripts were filed in this case on May 21, 2015. Accordingly, the attorney examiner now finds that post-hearing briefs should be filed by June 22, 2015, and reply briefs by July 7, 2015.

It is, therefore,

ORDERED, That post-hearing briefs be filed by June 22, 2015, and reply briefs by July 7, 2015. It is, further,

ORDERED, That a copy of this Entry be served upon all parties of record.
