EDF Industrial Power Services (OH), LLC ("EIPS OH") is certified as a competitive retail electric service ("CRES") provider pursuant to PUCO Docket No. 13-0327-EL-CRS. Pursuant to Ohio Administrative Code 4901:1-27-11, EIPS OH submits this notice of material change. Effective April 27, 2015, EIPS OH merged with its affiliate, EDF Energy Services, LLC ("EDF Energy Services"). EDF Energy Services is the surviving entity. EIPS OH requests that the Commission change the company name listed on its CRES certificate to "EDF Energy Services, LLC."


