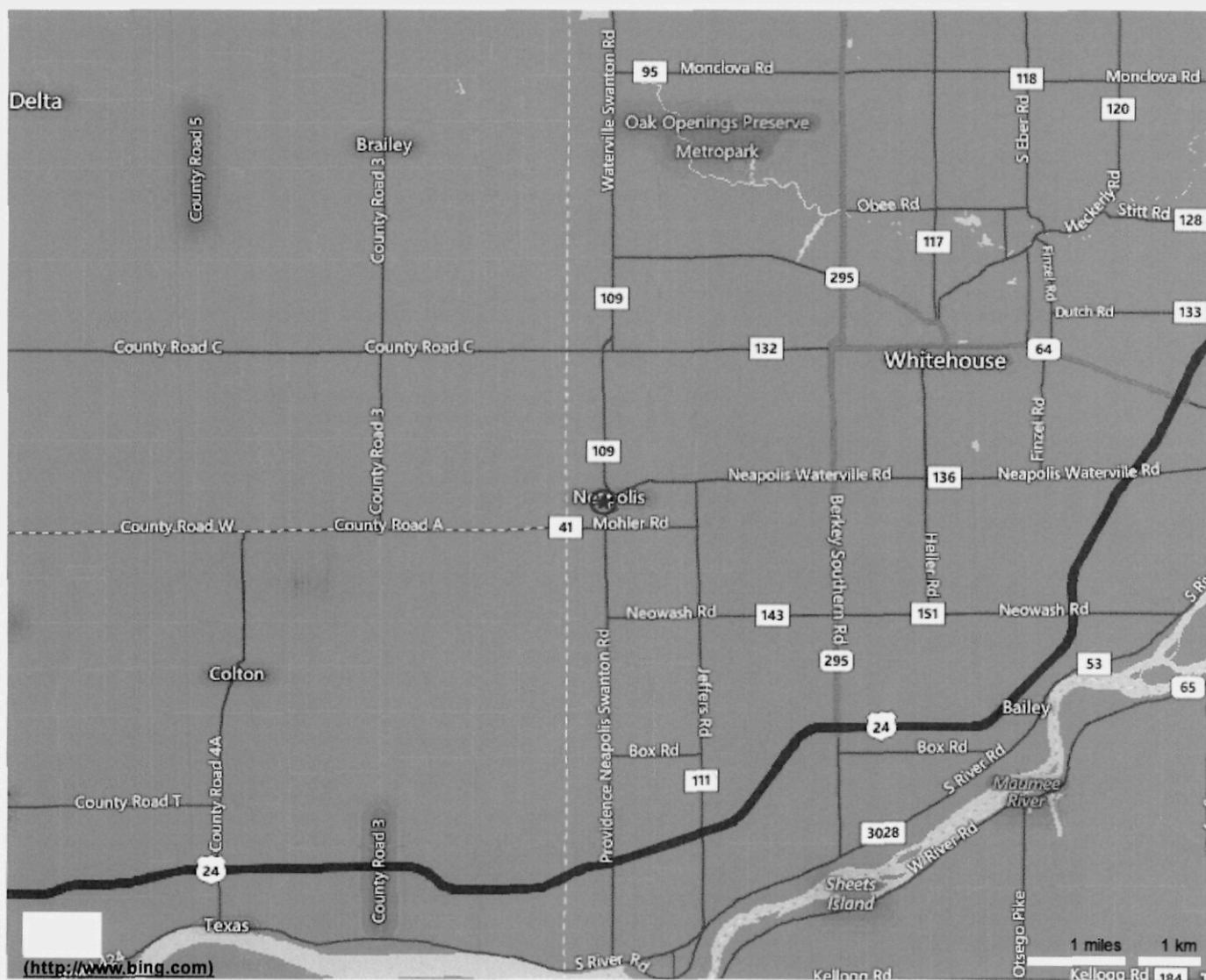
Map of Neapolis, OH

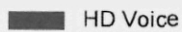
This map shows wireless voice coverage in the United States, Puerto Rico and the U.S. Virgin Islands.
