JOINT APPLICATION OF NOVA TELEPHONE COMPANY AND KCL, INC.

The NOVA Telephone Company (“NOVA” or “Company”), Swag Construction, Incorporated, VNC Enterprises, LLC, and KCL Incorporated (“KCL”), respectfully submit this application for transfer of control (“Application”) of NOVA from Swag Construction, Incorporated and VNC Enterprises, LLC (“VNC”), to KCL, pursuant to Ohio Revised Code 4905.402 and Ohio Administrative Code 4901:1-6-29.

THE JOINT APPLICANTS:

1. NOVA is an Ohio telephone company, and incumbent local exchange carrier, and a public utility subject to the jurisdiction of the Public Utilities Commission of Ohio (“PUCO or “Commission”). NOVA provides local exchange telephone service and other services in and around the village of Nova, Ohio (located within Troy Township in Ashland County). NOVA has provided services to the area from 1912 through the present day.
2. NOVA is a “telephone company” within the meaning of Ohio Revised Code Section 4905.402(A)(4) and a “domestic telephone company” within the meaning of Ohio Revised Code Section 4905.402(B).

3. The authorized capital stock of NOVA consists of five thousand (5000) shares, of which fifty-seven (57) shares are outstanding and four thousand nine hundred forty-three 4,943 shares are held in treasury. NOVA's largest shareholder, Swag Construction, Inc. ("Swag") owns 100% of the issued and outstanding shares of NOVA. Swag is wholly owned by VNC. VNC is owned by Charles D. Mattingly, Jr. Thus, VNC indirectly controls NOVA through its ownership of Swag.¹
4. KCL is a Texas corporation with its principal place of business in Longview, Texas. KCL currently has no operating interests in the State of Ohio. The managing member of KCL is Charles D. Mattingly Jr. Mr. Mattingly owns 90% of KCL and Kimberly Starr owns 10% of KCL. KCL owns Dunnell Telephone Company, which provides telephone service in the Dunnell exchange area in Mankato, Minnesota. KCL owns other affiliates that are not regulated telecommunications providers.
5. As required, a Certificate of Good Standing for NOVA is provided as Attachment A. The Texas equivalent of a good standing certificate for KCL is provided as Attachment B.²

THE PROPOSED TRANSACTION:

6. Upon approval of this Application by the PUCO, KCL will purchase the ownership shares of NOVA held by Swag. Thus, all interests and holdings related to NOVA and currently held by VNC will be transferred to KCL. Upon the closing of this transaction, VNC and Swag will be dissolved and will cease to exist. KCL will be the sole and direct

owner of NOVA, and would thereby be deemed to “acquire control” of a “domestic telephone company” within the meaning of Ohio Revised Code Section 4905.02. As such, the transaction is expressly subject to approval by this Commission and the Federal Communications Commission.

7. While the transaction Agreement contains terms and conditions relating to the operations of NOVA, it also contains extensive terms and conditions considered proprietary by the parties. Accordingly, the Agreement is not an exhibit or attachment to the Application.

CONTINUING OPERATIONS:

8. NOVA’s day-to-day operations will remain unaffected by the proposed transaction, and the financial structure of NOVA will not change in any material way.
9. Further, the ultimate acquisition of NOVA’s stock by KCL will not change or relocate, in any respect, by operation of law or otherwise, NOVA’s operations, business locations, or non-management employees.
10. Upon completion of the proposed transaction, NOVA will remain a “domestic telephone company” and will remain subject to the jurisdiction of this Commission. The tariffs, rates, terms and other conditions of service provided by NOVA will be unaffected by the proposed transaction.
11. Because the proposed transaction and Agreement will not affect NOVA’s operations in any material way:
 - NOVA will continue to provide the same excellent quality of service to its customers that it has for over 100 years;
 - NOVA’s local presence and its day-to-day operations will be largely unaffected;

- NOVA's books and records will be retained in Longview, Texas, but will be available for review in Ohio immediately as requested or required by this Commission;
- NOVA's market power will be unaffected.

FUTURE OPERATIONS:

12. KCL will operate NOVA in a manner virtually transparent to its customers, by continuing to provide the same services at the same rates, terms, and conditions.

Under KCL, NOVA will continue to provide the same quality telecommunications and customer service that NOVA's customers have come to expect. Mr. Mattingly has operated or assisted in the operation of NOVA through VNC since 2010. Ms. Starr has assisted Mr. Mattingly by performing day-to-day operations and managing NOVA for more than two years. Mr. Mattingly and Ms. Starr will continue to operate NOVA in a manner that will allow it to compete successfully in the rapidly changing telecommunications industry.

13. With Mr. Mattingly and Ms. Starr at the helm, KCL has the financial, technical and managerial resources necessary to ensure that NOVA continues to provide reliable telecommunications service. Thus, the proposed transaction will have no impact on the Company's customers or the service they receive. The only significant impact of the proposed transaction is that NOVA will have a new owner (KCL). The change in control will promote public convenience by allowing NOVA, under new ownership, to continue to provide quality, uninterrupted service to NOVA's customers.

14. No changes in personnel, policy or operation of the Company will take place as a result of the proposed transaction. As required, a list of the names, addresses and phone numbers of officers, directors and partners for KCL is provided as Attachment C.

NOTICE TO CUSTOMERS:

15. As described above, the proposed transaction will not result in any changes in any operations of NOVA, and will therefore be "transparent" to NOVA's customers. Nonetheless, after the transaction is approved as herein requested, the Joint Applicants will provide notice to customers upon closing of the transaction contemplated by the Agreement and will file such notice in this proceeding. The notice will take the form of a bill insert or a mailing to customers, as hereafter determined by the Joint Applicants.

THE JOINT APPLICANTS REQUEST APPROVAL OF THE PROPOSED TRANSACTION:

16. As demonstrated above, the proposed change in control of NOVA will allow Mr. Mattingly and Ms. Starr to continue to oversee and ensure the provision of uninterrupted, high-quality service to the Company's customers. KCL possesses the technical, managerial and financial expertise and capabilities necessary to successfully manage and operate NOVA. KCL will continue the best attributes of NOVA to its customers and continue the provision of resources and expertise that NOVA will require to continue its success in the future.

17. Accordingly, the NOVA Telephone Company and KCL Incorporated, along with VNC Enterprises, LLC, and Swag Construction, Incorporated, now respectfully request that this Application for the transfer of control of NOVA from VNC to KCL be approved.
