APPLICATION OF SUBURBAN NATURAL GAS COMPANY

Now comes Suburban Natural Gas Company ("Suburban" or "Company") and respectfully requests the approval of the Public Utilities Commission of Ohio ("PUCO" or "Commission") for authority to revise Section V, Third Revised Sheet No. 6 of its Tariff, Gas Service Interim, Emergency and Temporary Percentage of Income Payment Plan ("PIPP") Tariff Schedule Rider from the current rate of (0.1865054 per Mcf), which is currently a refund, to a charge of \$0.0587956 per Mcf, which is a change of greater than +/- 10%. In support of this request, Suburban states as follows:

- Suburban is a public utility and a natural gas company providing service to customers in Ohio and is subject to the jurisdiction of this Commission under Sections 4905.02 and 4905.03, Revised Code.
- 2. By this Application, and consistent with the Orders of the Commission authorizing Suburban's PIPP Rider, Suburban requests authorization to modify this Rider. A copy of the proposed PIPP Rider, Fourth Revised Tariff Sheet No. 6, is included as Attachment 2 to this Application, in both proposed and redlined forms.

- 3. Suburban's current PIPP rider became effective on January 1, 2014 in Case No. 13-2123-GA-PIP. Calculations supporting the modified rate are attached as Attachment 1.
- 4. In accordance with the procedure recommended in the direct testimony of the Commission Staff in Case Nos. 88-1115-GE-PIP, and the procedure established by Entry dated June 24, 1993 in Case No. 93-1000-EL-EFR, Suburban could implement the proposed PIPP Rider on August 17, 2015, on a bills rendered basis, absent action by the Commission.²

The charge of \$0.0587956 per Mcf is just and reasonable for the PIPP Rider and should be approved by the Commission or allowed to be implemented by Suburban absent Commission action as described above.

WHEREFORE, Suburban respectfully requests that the Commission approve an increase of the PIPP Rider to the rate set forth in the revised tariff sheet contained in Attachment 2 of this Application.
