Dear Ms. McNeal:

The November 24, 2014, Opinion, Order, and Certificate (“Certificate”) approving NTE Ohio, LLC (“NTE”) Certificate of Environmental Compatibility and Public Need to Construct the Middletown Energy Center established a set of conditions as part of the Certificate. This letter is to confirm that NTE is in compliance with the following conditions:

Condition No. 5 requires the Applicant shall use inert gases or compressed air for all cleaning of pipes during construction, consistent with the National Fire Protection Association 56 (PS) Standard for Fire and Explosion Prevention during Cleaning and Purging of Flammable Gas Pipeline Systems. NTE’s Engineering, Procurement and Construction (“EPC”) contractor, Gemma Power Systems, LLC (“Gemma”) will comply with the national standards listed above.

Condition No. 10 requires the Applicant to follow TTL Associates recommendations in the design and construction of the proposed facility. If project criteria or locations change, a geotechnical engineer should be permitted to determine whether the recommendations must be modified. NTE’s EPC contractor, Gemma agrees to follow TTL Associates’ recommendations.

Condition No. 11 states in part that the Applicant shall repair damage to government-maintained (public) roads and bridges caused by construction activity. Any damaged public roads and bridges shall be repaired promptly to their preconstruction state. Applicant will promptly repair any damage to their preconstruction state.

Condition No. 12 requires the Applicant shall not conduct any in-water work in perennial streams from April 15 to June 30 to reduce impacts to indigenous aquatic species and their habitat. There is no in-water work planned for perennial streams during the construction of the facility.
