My average electric bill has risen \$35/mo now with no caps or aggregate in site. How are they allowed NO restraint? There is no more bidding on the market and price locks. There are no more price locks. There are no more negotiated local aggregates. Why is Ohio Edison (and others) allowed this free reign of terror now??? I have taken huge steps into reducing my electric usage already. New appliances, Geothermal heating and cooling, reduced wattage elements in my water heater, reduced temperature of my water heater and installed CFL and LED low wattage lighting. Ohio residents are HURTING. Most can not afford to take the steps that I have. My average winter bill will rise \$76 just at todays rate. The compare and save for electric cost is a joke.
