Please accept this Application as notification that ACN Communication Services, Inc. ("ACN" or "Company") is changing the Company name to ACN Communication Services, LLC. ACN was granted a Certificate of Public Convenience and Necessity to provide interexchange and local telecommunication services, Certificate Number 90-9227, issued pursuant to Case Numbers 00-441-CT-ACE and 02-2065-TP-ACE.

On July 24, 2015, ACN Communication Services, Inc., a Michigan corporation, underwent a statutory conversion to become ACN Communication Services, LLC, a Michigan limited liability company. The conversion of the Company to a limited liability company was merely a change in its corporate form accomplished through the filing of a Certificate of Conversion in Michigan and did not entail any merger or other transactions interrupting the existence of the Company. Included with this Application is a copy of the Certificate of Conversion and a copy of the Registration as a Foreign Limited Liability Company issued by the Ohio Secretary of State.

The change in corporate form will be transparent to the customer and have no customer impact, as the name reflected in all customer communications (bills, notices, customer service, etc.) will remain "ACN Communication Services." Therefore, customer notice was not required. However, a bill message notice is being provided to customers stating: "ACN Communication Services, Inc.' has converted to a limited liability company and its name is now 'ACN Communication Services, LLC'. This change will be processed by the appropriate authority(ies) in your state, but it will not affect your service or rates, including any of your rights or obligations."

The Company respectfully requests the Commission to change the Company's name in all Commission records to ACN Communication Services, LLC and an effective date of October 21, 2015.
