**MOTION OF AFFILIATED POWER PURCHASERS INTERNATIONAL, LLC  
FOR AN EXTENSION OF THE EXPIRATION DATE OF ITS CERTIFICATE  
AND REQUEST TO CONTINUE OPERATIONS**

Affiliated Power Purchasers International, LLC (“APPI”) respectfully requests the Public Utilities Commission of Ohio (“Commission”) to extend the expiration date of APPI’s Certificate No. 01-062E (7), which authorizes APPI to provide aggregation and power broker services in the State of Ohio. APPI’s current certificate expired on August 1, 2015.

In compliance with Ohio Administrative Code (“OAC”) Rule 4901:1-24-09(A), and in order to allow for the 30-day review process of a new application delivered to the Commission on September 23, 2015, APPI respectfully requests that the Commission extend the expiration date until October 23, 2015.

WHEREFORE, APPI respectfully requests that the Commission grant it an extension of the expiration date of Certificate No. 01-062E (7), and authorize APPI to continue to operate under its Certificate during the pendency of the new certification application.

**MEMORANDUM IN SUPPORT**

---

APPI is an independent consulting firm that assists electricity users by providing education, market information, and access to supply contracts offered by retail suppliers. APPI has been an Ohio certified competitive retail electric service provider since 2001, and currently manages 8.1 billion kilowatt hours and 12.3 million dekatherms for 2,300 clients across the United States. APPI's Certificate No. 01-062E (7), authorizing it to continue to provide aggregation and power broker services for the two year period, was renewed commencing August 1, 2013. APPI was required to file its application to renew its certificate 30 days prior to August 1, 2015. Unfortunately, due to personnel changes and an inadvertent administrative error, APPI failed to file its renewal application as required by OAC Rule 4901:1-24-09. Thus, APPI's certificate expired August 1, 2015.

The Commission has plenary authority to extend the expiration date of APPI's certification for good cause shown. APPI's tardiness in filing its renewal application was solely due to an inadvertent administrative error. APPI takes its responsibilities, including timely filing applications for renewal on a timely basis, seriously. APPI apologizes for its administrative error and has taken internal steps to prevent it from occurring again. APPI sent a new application to the Commission via overnight Federal Express delivery, on September 22, 2015, as evidenced by the attached cover letter.

THEREFORE, in order to facilitate this filing, and to insure that APPI will be able to continue to provide service to its customers in Ohio during the pendency of the new application, APPI requests a 30 day extension of its Certificate 01-062E (7) to October 23, 2015 and authority to continue to operate during the pendency of the new certificate application.
