MOTION FOR PERMISSION FOR MARK R. ORTLIEB  
TO APPEAR *PRO HAC VICE* FOR AT&T OHIO

---

Pursuant to Rule 4901-1-08(B) of the Ohio Administrative Code, Mark R. Ortlieb moves for permission to appear *pro hac vice* in this proceeding as an attorney for AT&T Ohio and states that:

1. Rule 4901-1-08(B) of the Ohio Administrative Code permits out-of-state attorneys to practice before the Commission and provides as follows:

An out-of-state attorney may seek permission to appear *pro hac vice* before the commission in any activity of a case upon the filing of a motion. The motion shall include all the information and documents required by paragraph (A)(6) of section 2 of rule XII of the Rules for the Government of the Bar of Ohio.

2. Paragraph (A)(6) of section 2 of Rule XII of the Rules for the Government of the Bar of Ohio provides as follows:

(6) The attorney may file a motion for permission to appear *pro hac vice* accompanied by a copy of the certificate of *pro hac vice* registration furnished by the Office of Attorney Services, and includes the following information:

(a) The attorney's residential address, office address, and the name and address of the attorney's law firm or employer, if applicable;

(b) The jurisdictions in which the attorney has ever been licensed to practice law, including the dates of admission to practice, resignation, or retirement, and any attorney registration numbers;

(c) An affidavit stating that the attorney has never been disbarred and whether the attorney is currently under suspension or has resigned with discipline pending in any jurisdiction the attorney has ever been admitted;

(d) A statement that the attorney has not been granted permission to appear *pro hac vice* in more than three proceedings before Ohio tribunals in the current calendar year pursuant to Section 2(A)(5);

(e) The name and attorney registration number of an active Ohio attorney, in good standing, who has agreed to associate with the out-of-state attorney.

3. Mr. Ortlieb's residential address is 4240 North Hermitage, Chicago, Illinois 60613. He is employed as a General Attorney by AT&T and his office address is 225 West Randolph, Floor 25, Chicago, Illinois 60606.

4. Mr. Ortlieb is licensed to practice law in Michigan. He was admitted to the Michigan Bar on December 28, 1982 and his Michigan Bar number is P34962.

5. Mr. Ortlieb is also licensed to practice law in Illinois. He was admitted to the Illinois Bar on May 5, 1983 and his Illinois Bar number is 6184447.

6. Attached to this Motion is an Affidavit of Mark R. Ortlieb stating that Mr. Ortlieb has never been disbarred, is not currently under suspension and has not resigned any bar membership with disciplinary proceedings pending against him.

7. Pursuant to Rule XII(2)(A)(5) of the Rules for the Government of the Bar of Ohio, Mr. Ortlieb has been granted permission to appear *pro hac vice* in one proceeding before an Ohio tribunal in the current calendar year, that being PUCO Case No. 14-1964-TP-ARB.

8. Douglas W. Trabaris is an active Ohio attorney in good standing and has agreed to associate with Mark R. Ortlieb on this matter. Mr. Trabaris' attorney registration number is 0051289.

9. Mark R. Ortlieb received a Certificate of Pro Hac Vice Registration from the Supreme Court of Ohio. A copy of that certificate is attached.

WHEREFORE, Mark R. Ortlieb respectfully requests that he be permitted to practice before the Commission in the above styled proceeding.



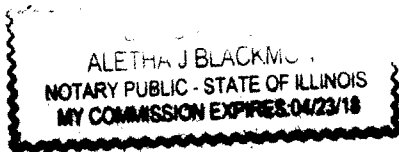


