**MOTION FOR FURTHER EXTENSION OF TIME  
FOR THE FILING OF REPORT**

---

The Staff of the Public Utilities Commission of Ohio respectfully requests that the date for the filing regarding AEP Ohio's purchase of receivables (POR) program ordered in this matter be extended. Specifically, Staff requests that it be permitted an additional 30 days, or until Monday, November 16, 2015, to make that proposed POR program ordered filing. This request is made pursuant to O.A.C. 4901-1-13(A).

In its February 25, 2015 order, the Commission approved a purchase of receivables (POR) program. In doing so, the Commission noted that the Market Development Working Group (MDWG) would provide an existing forum for discussion regarding the implementation of AEP Ohio's POR program. It further directed Staff to report on the progress of such discussions. Specifically, the Commission directed that AEP Ohio, Staff, and any other interested stakeholders, make a filing, in a new docket, by August 31, 2015

proposing the specific discount rate to be initially established, as well as a detailed implementation plan for the POR program, for the Commission's consideration. The Commission has now opened that new docket, as Case No. 15-1507-EL-EDI.

By Entry dated September 2, 2015, the initial deadline was extended to October 15, 2015. Because of the press of other business, Staff remains unable to meet the ordered deadline. Staff represents that it should be able to complete the directed recommendations within the requested extension period.

WHEREFORE, Staff respectfully request that the date for the filing regarding AEP Ohio's purchase of receivables (POR) program ordered in this matter be extended by additional 30 days, or until Monday, November 16, 2015.
