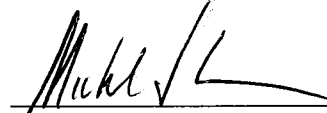

Mr. Lisowski shall bring documents, including but not limited to, his filed rebuttal testimony in this proceeding, any documents relied upon or cited in his rebuttal testimony, and any workpapers that support his rebuttal testimony.

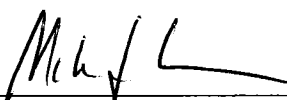
