

MOTION FOR EXTENSION

Pursuant to Rule 4901:1-27-09(B) of the Ohio Administrative Code, Choose Energy, Inc. ("Choose Energy") seeks an extension of Certificate No. 13-331G (1) which was issued in Case No. 13-2092-GA-AGG. The expiration date of Certificate No. 13-331G (1) is November 15, 2015. Due to the press of other business, Choose Energy was not able to file its renewal application on time. It has now filed its renewal application on October 30, 2015 which is not later than the November 15, 2015 expiration date of its current certificate. Choose Energy respectfully requests that Certificate No. 13-331G (1) be automatically extended from November 15, 2015 until November 29, 2015 or until the date that the new certificate is issued.

WHEREFORE, Choose Energy respectfully requests that Certificate No. 13-331G (1) be automatically extended to November 29, 2015 or until a new certificate is issued and authorize it to continue to operate during the pendency of the renewal application certification review, so that there will be no interruption in service to customers.



Rule 4901:1-27-09(B) provides that a motion requesting an extension of a certificate will be deemed automatically approved (unless ruled otherwise by the Commission or an Attorney Examiner within three business days), if a renewal application is filed fewer than thirty calendar days prior to the expiration date of the certificate but no later than the expiration date. Choose Energy submits that it has met the criteria and respectfully requests an automatic extension of the expiration date of Certificate No. 13-331G (1) issued in Case No. 13-2092-GA-AGG to November 29, 2015 or until such time as a new certificate is issued so as not to interrupt service to customers.
