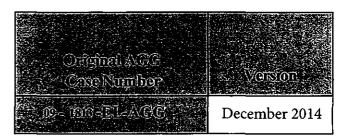

Experience

STEP Resources Consulting LLC ("STEP") was registered as a limited liability corporation ("LLC") in 2006 as an energy consulting firm focused primarily on demand side initiatives and regulatory representation on behalf of our clients. In late 2009, STEP established an office in Oxford, Ohio and expanded operations into the procurement market. In January 2013, STEP relocated its office to 8366 Princeton-Glendale Road., Suite B1, West Chester, Ohio 45069.

Since 2009, STEP has procured energy for over 100 clients, ranging from small commercial to large industrial users (communications, consumer goods, government, healthcare, industrial goods, real estate, services and technology). Such accounts comprise over 1 billion kWh in electricity usage in Ohio, California, Massachusetts, Illinois and New Hampshire.
