ENTRY

The Commission finds:

- (1) Pursuant to R.C. 4905.26, the Commission has authority to consider written complaints filed against a public utility by any person or corporation regarding any rate, service, regulation, or practice relating to any service furnished by the public utility that is in any respect unjust, unreasonable, insufficient, or unjustly discriminatory.
- (2) Ohio Adm.Code 4901-1-08, in relevant part, directs that corporations must be represented by an attorney-at-law in complaint cases before the Commission.
- (3) Based upon the pleadings filed by Seneca Builders, LLC (Seneca Builders or Complainant) initiating *In re Complaint of Seneca Builders, LLC v. Columbia Gas of Ohio, Inc.*, Case No. 13-124-GA-CSS, Entry (March 25, 2013) at 2-3, the attorney examiner found that Complainant appeared to be a corporation and, thus, directed Seneca Builders to have counsel file an appearance in the case by April 1, 2013. The attorney examiner noted that, should counsel fail to make an appearance on behalf of Seneca Builders by that date, the attorney examiner would recommend to the Commission that Case No. 13-124-GA-CSS be dismissed. Counsel made an appearance in the case on behalf of Seneca Builders on March 29, 2013.




- (4) Also on March 29, 2013, counsel representing Seneca Builders filed a new complaint docketed as *In re Complaint of Seneca Builders, LLC v. Columbia Gas of Ohio, Inc.*, Case No. 13-766-GA-CSS. The complaint in Case No. 13-766-GA-CSS made the same arguments set forth in Case No. 13-124-GA-CSS.
- (5) The Commission fully considered the arguments raised by Seneca Builders in Case No. 13-124-GA-CSS culminating in an Opinion and Order issued on January 14, 2015, and a Second Entry on Rehearing issued October 28, 2015. Insofar as the arguments raised by Seneca Builders have been fully litigated in Case No. 13-124-GA-CSS, Case No. 13-766-GA-CSS will now be dismissed.

It is, therefore,

ORDERED, That, in accordance with finding (5), Case No. 13-766-GA-CSS be dismissed. It is, further,

ORDERED, That a copy of this Entry be served upon all interested parties of record.


