The December 16, 2013 Opinion, Order, and Certificate approving Northwest Ohio Wind Energy, LLC's [now known as Trishe Wind Ohio, LLC ("Trishe")] Certificate of Environmental Compatibility and Public Need ("Certificate") and the October 1, 2013 Supplement to Amended Application ("Supplement") established a set of conditions and supplemental commitments as part of the Certificate.

Within this set of conditions and commitments, **Supplement Commitment No. 9** requires that:

**Prior to the commencement of construction activities that require permits or authorizations by federal or state laws and regulations, Applicant will obtain and comply with such permits or authorizations. Applicant will provide copies of permits and authorizations, including all supporting documentation, to Staff within seven days of issuance or receipt by the Applicant. Applicant will provide a schedule of construction activities and acquisition of corresponding permits for each activity at the preconstruction conference..**

In compliance with Supplement Commitment No. 9, attached for filing is a copy of the Paulding County driveway permit for construction at the substation site.
