MEMORANDUM IN SUPPORT

On December 4, 2013 PowerOne was granted Ohio Competitive Electric Retail Service Provider Certificate No. 13-762E (1), effective through December 2, 2015.

O.A.C. Rule 4901:1-24-09 provides that a renewal application be filed between 60 and 30 days before expiration of a competitive retail electric service provider certificate. Due to an administrative oversight, PowerOne's current renewal application was not filed by the November 2, 2015 deadline but was filed on [date]. Because the Rule contemplates at least 30 days for the Commission to review a renewal application, PowerOne requests an extension of the expiration date of its current certificate for a reasonable period of time so as to allow the Commission the opportunity to evaluate Applicant's renewal application. O.A.C. Rule 4901:1-24-02(C) allows the Commission to waive any of the rules in Chapter 4901:1-24, for good cause.
