## MEMORANDUM IN SUPPORT

By entry dated October 8, 2015, the Commission adopted a procedural schedule in this case setting dates for the filing of testimony and an evidentiary hearing as follows:

- a) **December 9, 2015** – Deadline for Staff and intervenors to file testimony<sup>1</sup>
- b) **December 16, 2015** – Deadline for Duke to file supplemental testimony
- c) **December 22, 2015** – Evidentiary hearing

For the reasons set forth below, Staff requests that the Commission amend the procedural schedule as follows:

- a) **January 6, 2015** – Deadline for Staff and intervenors to file testimony
- b) **January 13, 2015** – Deadline for Duke to file supplemental testimony
- c) **January 27, 2015** – Evidentiary hearing

Staff requests this extension because it would like more time to pursue a settlement among the parties. Due to the proximity of the upcoming filing deadline, Staff requests expedited treatment of this motion.
