Dear Mr. McKenny,

I would appreciate it if you would add these documents to Case Record 14-1160-EL-UNC.

I strongly oppose these 2-way transmitting wireless "smart" meters. They have had profound adverse effects on my entire family and I have already reported this in great detail to PUCO. There are too many studies from around the world that reiterate the same things:

"...the exposure to microwave and radiowave radiation from these (smart) meters is involuntary and continuous. The transmitting meters may not even comply with Federal Communications Commission (FCC) "safety" standards (see http://sagereports.com/smart-meter-rf/). However, those standards were initially designed to protect an average male from tissue heating (cooking) during a brief exposure. These standards were not designed to protect a diverse population from the non-thermal effects of continuous exposure to microwave and radiowave radiation. Therefore, these "safety" standards were not designed to protect the public from health problems under the circumstances which the meters are being used. The American Academy of Environmental Medicine has called for a moratorium on the installation of transmitting utility meters on the basis that:

"Chronic exposure to wireless radiofrequency radiation is a preventable environmental hazard that is sufficiently well documented to warrant immediate preventative public health action."

Is there anyone else I need to report this too in order for it to be considered? There are people who are very sick and they are now being turned down when they call Duke Energy to have their meters replaced while all of you at PUCO are negotiating with them on their "opt out" fees. I know first-hand what these sick people are going through. Every minute of every day counts when you are being constantly blasted with microwave radiation in the comfort of your home. Eventually you wonder how it will be possible that your body continues to operate. Most local doctors don't have answers because they aren't thinking about smart meters. There is no relief and eventually little hope. I am certain that I would have died within the week if my meters had not been replaced in less than 48 hours from making the request. I had no pre-existing health conditions or genetic issues that would have created this situation.

My primary care physician is an internist. She was voted one of the "Top Doctors" in Cincinnati. She knows all about environmental toxins. In July she told me she didn't know how to help me anymore because "nothing made sense". I was fortunate I heard about getting the meters replaced from someone else and made the call. I have improved significantly since these meters were replaced. But keep in mind – I was at rock bottom and I still may never be the same. I have 4 dead pets because of this and my father had to be moved into a nursing home over 2 years ago. I still don't know how it will affect my husband.

All of us have higher medical bills and are becoming more debilitated. The government has to pick up the bill for anyone who can't afford medical care. Seems like the only ones coming out ahead on this "smart" meter program are the utility companies who were able to save money by firing most of their meter readers.

The Energy Policy Act of 2005, Section 1252, "smart meters", states that electric utilities shall provide such meters to those customers who request them. Therefore, people should have to "opt in". There are people fighting these meters all across the country. There are class action lawsuits in California and Maine. The jig is up. This isn't "EMF Sensitivity." This is continuous radiation in almost every building in Ohio. I didn't agree to this and I don't know anyone else who did.

<u>With great power comes great responsibility</u>. Keep that in mind, Mr. McKenny. The clock is ticking and many Ohioans are running out of time. Some of them might actually be people you know and love.
