ENTRY

The attorney examiner finds:

- (1) On October 3, 2014, as amended on May 15, 2015, Ohio Power Company d/b/a AEP Ohio (AEP Ohio) filed an application seeking approval of a proposal to enter into a new affiliate power purchase agreement with AEP Generation Resources, Inc.
- (2) An evidentiary hearing in these proceedings commenced on September 28, 2015, and concluded on November 3, 2015. At the conclusion of the evidentiary hearing, a briefing schedule was established, and subsequently amended.
- (3) On December 14, 2015, AEP Ohio filed a joint stipulation and recommendation (stipulation) for the Commission's consideration. By Entry issued December 15, 2015, a procedural schedule for review of the stipulation was established and the briefing schedule held in abeyance.
- (4) Gov.Bar R. XII(2)(A) provides rules governing eligibility to practice pro hac vice in Ohio. Pursuant to Gov.Bar R. XII(2)(A)(6), motions for admission pro hac vice must be accompanied by a certificate of pro hac vice registration furnished by the Supreme Court Office of Attorney Services.
- (5) On December 4, 2015, a motion to appear pro hac vice, including a certificate of pro hac vice registration, was filed for David C. Rinebolt on behalf of Ohio Partners for Affordable Energy. The attorney examiner finds that the motion to admit Mr. Rinebolt is reasonable and should be granted.

It is, therefore,

ORDERED, That the motion to appear pro hac vice be granted. It is, further,

ORDERED, That a copy of this Entry be served upon all parties of record.
