# NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio Transmission Company, Inc., (AEP Ohio Transco) proposes to construct a new 138-kilovolt (kV) transmission line in Green Township in son County.

The purpose of the Rexford Extension 138-kV Transmission Line Project is to provide electricity to the Sunoco-Hopedale plant. AEP Ohio Transco to the Sunoco-Hopedale plant. AEP Onio Transco will build the new line using standard single 138-kV structures. The Rexford Extension 138-kV transmission line will be approximately two miles long. This project will be an approximate \$4 million investment by AEP Ohio Transco. Construction is scheduled to begin in January 2016.

The project is known as the Bexford Extension The project is known as the Rextord Extension 138kV Transmission Line Project. As required by Ohio Revised Code Section 4906-11-01, AEP Ohio Transco has filed a Letter of Notification with the Ohio Power Siting Board, under Case No. 15-2036-EL-BLN, This number should be included in all communications with respect to this project.

This project meets the requirements for a Letter of Notification because it is within the types of projects defined by Items (1)(f) of Attachment A of the interim process defined in the Ohio Power Siting Board's Sept. 4, 2012, Finding and Order in Docket 12-1981-GE-BRO. 

### CRITERIA USED TO REVIEW THE APPLICATION

The following eight criteria are set forth in Section 4906.10 (A) of the Revised Code and will be used, along with additional information, by the board in reviewing the application for a certificate to construct, operate and maintain the Rexford Extension 138-kV transmission line:

- The basis of need for the facility:

- The nature of the probable environmental impact of the proposed facility;

- The facility represents the minimum adverse environmental impact, considering the state of available technology, the nature and economics of alternatives and other pertinent considerations;

In the case of electric transmission lines, that the and the case of electric transmission lines, that the facility is consistent with regional plans for expansion of the electric power grid of the electric systems serving Ohio and interconnected systems, and that the facility will serve the interests of electric system economy and reliability;

- The facility will comply with chapters 3704, 3734 and 6111 of the Revised Code and all rules and standards adopted under sections 1501.33, 1501.34 and 4561.32 of the Bevised Code. In determining and 4561.32 of the Revised Code. In determining whether the facility will comply with all rules and standards adopted under Section 4561.34 of the Revised Code, the board shall consult with the offic of aviation of the division of multi-modal planning and programs of the Department of Transportation the office under Section 4361.341 of the Revised Code:

The facility will serve the public interest, convenience and necessity;

The facility's impact on the viability as agricultural land of any land in an existing agricultural district established under Chapter 929 of the Revised Code that is located within the site of the proposed major utility facility; and

- The facility incorporates maximum feasible water conservation practices as determined by the board considering available technology and the nature and economics of various alternatives.
