Constellation Energy Gas Choice, Inc. ("Licensee") submits this letter as notice to the Public Utilities Commission of Ohio ("Commission") that Licensee changed its name to Constellation Energy Gas Choice, <u>LLC</u> effective December 31, 2015 at 11:59 pm.

Licensee respectfully requests the Commission approve its legal name change to Constellation Energy Gas Choice, LLC, as Licensee's conversion from a corporation to an LLC and associated name is part of an ongoing corporate restructuring.

Given the fact that there will be no changes to any existing customer contracts and only minimal changes to marketing materials where the whole legal entity's name appears, rather than the shortened use of "Constellation", Licensee does not intend to send notifications to customers informing them of the name change. Further, the name change will not otherwise impact the legal ownership, or management of Licensee in any way. Licensee's DUNS number and Federal Tax Identification Number also remain unchanged.


