## FINDING AND ORDER

The Commission, coming now to consider the above-entitled matter and being fully advised in the premises, finds:

- (1) Public Service Corporation is a sewage disposal system company as defined by Section 4905.03 (A)(14), Revised Code and a public utility as defined by Section 4905.02, Revised Code. Public Service Corporation is, therefore, subject to the jurisdiction of this Commission.
- (2) On May 31, 1984, Public Service Corporation filed an Application Not For An Increase In Rates, pursuant to Section 4909.18, Revised Code to alter its Sewage Disposal Service Tariff, PUCO No. 1, Section 4, Original Sheet No. 2, Paragraph 4. The application was modified and supplemented by filings on June 5, July 18, and July 23, 1984.
- (3) The proposed alteration would correct an administrative oversight on the part of the Applicant in that not all references in the tariff to the reconnection charge were brought into compliance with the Commission's Opinion and Order of April 29, 1981, in Case No. 80-48-ST-AIR, when the present tariff was filed and approved in 1981.
- (4) Applicant's tariff currently reflects a \$50.00 reconnection charge in Section 4, 1st Revised Sheet No. 6, and in Section 5, 1st Revised Sheet No. 4. However in Section 4, Original Sheet No. 2 the reconnection charge is stated as being \$10.00. Applicant has advised the Commission that no situation has arisen since April 29, 1981, when it had occasion to charge a reconnection fee. The Commission finds that Section 4, Original Sheet No. 2 should be revised to reflect the \$50.00 reconnection charge as proposed by the Applicant, recommended by the Staff, and approved by the Commission in Case No. 80-48-ST-AIR.

## It is, therefore,

ORDERED, That Public Service Corporation is authorized to file in final form three (3) printed copies of its revised tariff which will supersede Section 4, Original Sheet No. 2. It is, further,

ORDERED, That the effective date of the new tariff shall be the date upon which Applicant files its tariff in final form. It is, further,

ORDERED, That nothing herein contained shall be deemed to be binding upon this Commission in any subsequent investigation or proceeding involving the justness or reasonableness of any rate, charge, rule or regulation. It is, further,
