PLEASE, PLEASE, PLEASE keep AEP from raising rates. I am on Social Security, living on a fixed income. My home is all electric, therefore, I am greatly concerned about any more hikes from AEP. In January of 2015, my electric bill was \$900. for just one month. Other months last year I had \$600. and \$700. bills. I called AEP over and over about how extraordinarily high this was and they continued to tell me it was cold and rates have increased. Yes, it was cold but I had never had a bill nearly that high in the 20+ years I've lived here. In previous years it had been high but never over \$500+ dollars a month when extremely cold. Should it be right that AEP takes half of my S.S. check in some months. Also note that I live in a very modest size home. I'm on oxygen so have to have my electric on at all times, including A/C in summer months. My S.S. is just slightly high enough to disqualify for assistance, but when qualifying for assistance, many things need to be taken into consideration. That being ones expenses, such as the medical bills I have to pay. Other than that, I don't have debt, but still can barely make it month to month only due to my electric bills. AEP threatened to shut off my power if I didn't pay those huge bills in a short period of time. I was forced to pay AEP by charging it to my Credit Card which I rarely use, which I have for emergencies, only. Guess electric has become an emergency for me. It just isn't right that I can go broke due to my electric bill. It affects me financially and physically since it is so upsetting. I never have the furnace temp at 70 degrees year round. Not an ideal temp for me, but I have to try to keep the AEP bill as low as I can.

PLEASE keep AEP from giving us any more rate hikes. It's nearly killing me now. I wish there was a way to get the present rates down. Certainly not up. I can't afford to live here strictly due to AEP costs, but I also cannot afford to move. My electric bill is the only thing that puts me in financial jeopardy. It just isn't right.
