Dear Commissioner Johnson,

I am WORN OUT after being an all electric home owner...one once since 1975.

I was there in Columbus at the PUCO hearing as a testifying (on the bench) witness a few years back regarding the all electric RGC discount 10-0176-EL-ATA, complete with copies of a letter from Cleveland Electric Illuminating (dated and postmarked envelope and addressed to me) for PUCO and FE to examine, saying I will always have my RGC discount as long as I live in my house. It was implied in the letter that the next person to move into my house probably will lose the discount. When testifying, the FE's lawyer implied that I didn't understand what the letter was really implying and simply blew it off to everyone involved as I didn't understand it. HUH.....It seemed pretty straight forward if one was to read only 2 sentences of the letter for themselves and not listen to the suggested implied response by the FE lawyer. Well I guess it is easier to LISTEN to a lawyer than to READ only a couple sentences out loud, or to themselves. Copies in PDF format are available if anyone reading this message would like the letter as well as addressed and post marked letter stated above. Chalk up one for lawyers...

Simply put, I have over the years gone from 5,500 kWh in the winter peak to around 1650 kWh usage. A very large reduction. Similarly in summer from 2300 to about 700 kWh. I can't get it down any further after costing me around \$35,000 out of my pocket to get my bills that greatly down on usage through major and minor improvements. I was doing this as an investment so when I retire, my bills should be reasonable on a fixed income. Well the current electric bills are far exceeding any inflation that might be encountered. An example as follows...Dec 2014, actual cost per kWh USED was 8.27 versus 10.22 cents for Dec 2015 bill. A 23.5% increase. It doesn't stop there, Jan 2014 6.82 cents, versus 9.4 cents Jan 2015. Wow, a 50% increase. If this keeps up, what next 60%, then 75% if and when PUCO might approve FE's current appeal to keep the old power plants open. Maybe my bills will go up 100% per kWh.

I don't want my electric bill to go up to pay for AEP's and FirstEnergy's old power plants. The utilities claim they're losing money on their aging plants, and now they're demanding that consumers cover the cost of their bad decisions not to invest in cheaper, cleaner power, like natural gas.

It's outrageous that my electric bill will go up while these giant utilities are earning billions of dollars and paying hefty dividends to their shareholders. Please stand up for Ohio consumers and tell the PUCO to reject AEP's and FirstEnergy's money grab before the lawyers can chalk up a BIGGIE win number 2.

I am respectful of lawyers, but watch out PUCO, read, read, and don't simply listen. It is easy to be swayed. I have kept this to one page because most people won't bother to read it if it exceeds one page. Please read out of respect. Thank you in advance....
