## **ENTRY**

The attorney examiner finds:

- (1) On December 23, 2014, Complainant, Janice L. Guess, filed a complaint against Respondent, Ohio Power Company d/b/a/ AEP Ohio (AEP Ohio). Briefly summarized, the complaint alleges, among other things, that Respondent: (a) unlawfully disconnected power at Complainant's residence; (b) engaged in meter reading and billing activities, which include sending to Complainant's home unidentified employees who acted in an unruly and hostile manner and engaged in alleged trespassing and suspected vandalism of Complainant's private property; and (c) acted in such a manner as to impinge upon the Complainant's and her mother's health, safety, and comfort, within their own home.
- (2) On January 9, 2015, AEP Ohio filed its answer, denying all of the allegations of the complaint and raising several affirmative defenses.
- (3) A settlement conference was scheduled for and held on March 10, 2015. However, the parties were unable to resolve the dispute at that time.
- (4) By Entry issued January 25, 2016, a hearing in the case has been scheduled to occur on February 16, 2016, at 10:00 a.m. at the offices of the Commission.

(5) On February 11, 2016, the attorney examiner was notified that Complainant would not be able to attend the hearing scheduled for February 16, 2016.

(6) The attorney examiner finds that the hearing currently scheduled for February 16, 2016, should be postponed and will be rescheduled to occur on a date to be established in an entry to be issued in this case in the near future.

It is, therefore,
