Dear Ms. McNeal:

Frontier North, Inc. and CenturyLink (the "Joint Applicants") propose a boundary change for the Fort Recovery exchange of Frontier North Inc. and the Rossburg exchange of CenturyLink. This application is being filed pursuant to Ohio Administrative Code §4901:1-6-32(B). Joint applicants will work with the Commission Staff to revise the topographical maps to reflect a change in a small section of the Frontier Fort Recovery exchange into the Rossburg exchange of CenturyLink. This change is per a customer request and will accommodate the one address included in this request. .

This boundary change affects an area North of County Rd 705 at the intersection of Riegle-Bell Rd. Set forth below is the proposed boundary change:

- The southern boundary line of Frontier's Fort Recovery exchange to be moved 800 feet north from its current location at the intersection of County Rd. 705 and Riegle-Bell Rd, to incorporate the existing residence located at 14558 Riegle-Bell Rd. (See enclosed map) so that this area is incorporated into the CenturyLink Rossburg exchange.

The Joint Applicants are in concurrence with this change, and confirm that this change will not adversely affect the service being furnished to any existing subscriber.
