Dear Representative Hood,

In 1974 Gavin Power Plant (2 units) rated at 2600 MW cost 660 million dollars. In 1980 Mountaineer Power Plant (1 unit) rated at 1300 MW cost 990 million dollars. So if you total the " generation years " of these 2 locations in at 78 generation years and producing a total of 3,900 MW. If you run the numbers at the average of the cost of a kilowatt hour being .07 cents over 78 years comes to 27.3 billion dollars! This is just at 2 facilities when AEP has 90 + facilities generating 27 billion MW. Just the 2 locations that I've mentioned were long ago paid for, (Gavin 1981), (Mtn. 1987) and have generated profits since those dates for AEP. AEP planed on generating units to last 50+ years on the life of these units and substantially made the company profit. If the PUCO grants AEP's request will mean higher profits for them and higher electric bills for us. Do we really think that in 8 years those added " tariffs " will come off our bills? Or as in the past other requests and fees will be added to take their place? AEP has posted record profits and dividend payouts for 37 years straight, posting zero losses, (remember the storm of 2008) when they charged us for the repairs all the while the had insurance to cover those losses, where was the PUCO then? Now is the time that the PUCO stands up for us, let us catch up on our finances to allow for a family of 4 to be able to afford a day seeing a Cincinatti Reds baseball game.
