**MEMORANDUM IN SUPPORT**

---

The Commission issued Certificate No. 14-784E(1), which certified Harlem Township as a competitive retail electric service provider to provide governmental aggregation services effective March 2, 2014. By its terms, the certificate will expire on March 2, 2016. Unfortunately, given the unavailability of some township trustees due to illness and travel, a renewal application to extend the effectiveness of the certificate will not be filed within the time period prescribed by Ohio Adm. Code 4901:1-24-09(A). Accordingly, additional time is needed to prepare the renewal application and compile the supporting exhibits.

In order to afford Harlem Township the requisite time to file its renewal application, Harlem Township requests an extension of its Competitive Retail Electric Service Provider Certificate by 30 days to April 1, 2016. Consistent with Commission precedent, Harlem Township requests that the Commission extend the expiration date of the certificate to encompass the entirety of its review of the forthcoming renewal application so that if the renewal application is approved, there will be no break in Harlem Township's certification.<sup>1</sup> An extension will not prejudice any party.
