Examiner Sheets:

This letter is in regards to the Staff Comments filed on March 21, 2016, in the above mentioned cases regarding Duke Energy Ohio, Inc.'s Accelerated Main Replacement Program (AMRP) and the riser application. Staff inadvertently used Duke's Notice of Intent instead of the Application in its preparation of the Comments. Accordingly, the following are necessary corrections to Staff's Comments:

In Staff Comments on page 6:

- Where Staff states Duke's combined revenue requirement is \$32,844,381.45, the actual combined revenue requirement should be \$32,501,625.96;
- Where Staff states Duke proposed AMRP rate for residential customers is \$3.84, the actual rate for residential customer should be \$3.80; and
- Where Staff states Duke's rate for general service and firm transportation customers is \$35.48, the actual rate for general service and firm transportation customers should be \$35.17.

In Staff Comments on page 8:

- Where Staff states the residential rate is \$3.84 per month, the actual residential rate should be \$3.80 per month; and
- Where Staff states the general service and firm transportation rate is \$35.48, the actual general service and firm transportation rate should be \$35.17.

The new dollar amounts mentioned above will replace the incorrect amounts in Staff's Comments filed on March 21, 2016 in these matters. Please feel free to contact me if you have any additional questions.
