AMENDED MOTION TO EXTEND CERTIFICATION

In accordance with Ohio Adm. Code 4901:1-27-09(B), Harlem Township Trustees (Delaware County, OH) (hereinafter Harlem Township) files this motion for an extension of Certificate No. 14-345G(1) issued by the Public Utilities Commission of Ohio (Commission), which certified Harlem Township as an Ohio natural gas governmental aggregator to provide governmental aggregation services effective March 3, 2014. Harlem Township requests that the Commission extend the certificate so that it will remain effective up through and including at least April 28, 2016 (or such longer time as the Commission deems necessary to perform its review).¹ The basis for this motion is set forth in the accompanying memorandum in support.

MEMORANDUM IN SUPPORT

The Commission issued Certificate No. 14-345G(1), which certified Harlem Township as an Ohio natural gas governmental aggregator to provide governmental aggregation services effective March 3, 2014. By its terms, the certificate was supposed to expire on March 3, 2016; however, on March 1, 2016, Harlem Township filed a motion to extend the expiration date of its certificate while it prepared the renewal application and compiled the supporting exhibits.² The extension was requested because of the unavailability of some township trustees due to illness and travel.³

In order to continue the effectiveness of Harlem Township's certificate and to provide Staff adequate time to review the renewal application, Harlem Township requests another extension of its Ohio Natural Gas Governmental Aggregator Certificate from the date of the filing of its March 28, 2016 renewal application, up through and including at least April 28, 2016 (or such longer time as the Commission deems necessary to perform its review). The extension is in accord with Commission precedent and will not prejudice any party.⁴
