I. Introduction

Pursuant to Chapter 4901:1-40 of the Ohio Administrative Code (“OAC”), Alternative Energy Portfolio Standard, Competitive Retail Electric Service providers are required to file an annual compliance status report, as addressed in OAC 4901:1-40-05 and a forward-looking compliance planning document, as addressed in OAC 4901:1-40-03(C). Inspire Energy Holdings, LLC (“Inspire Energy”) hereby submits copies of both reports prior to the April 15<sup>th</sup> deadline.

II. Annual Compliance Status Report

The 2015 Statutory Compliance Obligation requires a Non-Solar Renewable Benchmark of 2.5%, and a Solar Renewable Benchmark of 0.12%. Please see the attached Summary Sheet indicating Inspire Energy’s 2015 sales and compliance obligation. With zero sales in Ohio in 2014, 2013, or 2012, Inspire Energy is not obligated to purchase any RECs or Solar RECs to successfully meet Ohio’s RPS Compliance Obligation.


III. Forward-Looking Compliance Planning Document
