Dear Siting Board Members:

I am writing in opposition of Duke Energy's pre-application for Case #16-253-GA-BTX. I am appalled the Ohio Power Siting Board is even considering a utility scaled sized project of this magnitude to go through a densely populated residential area such as mine in the Tangleridge subdivision of Blue Ash, Ohio. I have resided in this peaceful residential area since 1986.

As a licensed General Contractor/Master Electrician: Ohio License #10597 and North American Board Certified Energy Practitioner (NABCEP Certificate #091310-139), I have done the math.

One would wonder, how much Energy does a Natural Gas pipeline with a 30 inch diameter, 720 PSI distribution line produce?

- 1. 30" NG Pipe at 720 PSI = 550,000 Deka Thermal Units/day (DTH/day)
- 2. 550,000 DTH/day = approximately 3,000 Megawatts/day (MW/day)
- 3. 1 MW of electricity can power 164 houses/day.
- 4. 492,000 homes/day equates to enough Natural Gas for the conversion of FIVE(5) or more Coal Fired Power Plants.
